Item 6.a North Bowden Signage Councillor Sheila Church discussed that the existing signage located on the north end of Bowden is not very visually appealing. She asked that a new Town of Bowden sign be installed and that it be designed in such a way as to allow other local businesses to advertise on it. Andy Weiss pointed out that in the past; Alberta Transportation has denied attempts to get permission for a sign in this area. Andy was directed to ask again and if not right adjacent to Highway 587, another

location in that area may be allowable. He was also directed to obtain quotes for a potential sign and then report back to Council when further information was available.

Motion 6.a Moved by Councillor Cory Jasper that Council directs Administration to obtain quotes for a new sign at the north end of Bowden as per Council discussions. **MOTION CARRIED**

Item 6.b Rest Stop Councillor Sheila Church discussed that with the recent provincial elections, there may be a new potential for new funding from the Provincial Government to assist the municipality with the ongoing operation and maintenance of the Bowden Rest Stop. Councillors all pointed out that this facility costs significantly more to operate than we receive in provincial funding. As well, the building is in desperate need of major renovations.

Motion 6.a Moved by Councillor Steve Blamire that Council directs Administration to draft a letter to the Transportation Minister, asking for additional funding to support operation and maintenance of the Bowden Rest Stop, as per Council Discussions. **MOTION CARRIED**
