**Item 6.a Speed Zone Signage on Westview Drive** Several years ago, when the new houses were being constructed along the South end of Westview Drive and on the South end of 21<sup>st</sup> Street, Council asked that a 20 km/hr. speed zone sign be placed on Westview Drive at 15<sup>th</sup> Avenue as per the attached picture. Now that Subdivision construction has been completed for Phase 1B of Destination Greens, it is time for Council to re-visit this signage. The biggest issue that arises is that enforcement of this speed zone is difficult and there is no other location in town where the posted speed limit is at 20 km/hr.
